### **Climate Covenant**

As people of faith, we have an obligation to care for God's creation. How we live in this world has meaning and consequences for all beings.



We find our planet in a dire climate crisis. All life forms are at risk because of humankind's abuses of

the earth, sky and water. Millions of plant and animal species face extinction. Humans are suffering, especially those who already are oppressed and therefore less able to cope with the changes brought by a warming world.

We are called to action that reflects our abiding love for God, for one another and for the natural world. We pledge ourselves – as individuals and as the congregation of Missoula First United Methodist Church – to the interconnected responsibilities of caring for creation and seeking justice for the oppressed. All aspects of our congregation's life will reflect these deep and unwavering commitments.

Therefore:

1. We resolve to accept our moral obligation to be responsible stewards of God's creation and advocates for social justice. We will transform our despair, anger and sadness about climate change and human suffering into action that helps to heal our world and all of humanity.

2. We resolve to conduct a review of our church's carbon footprint, and to develop and enact practices that reduce our impact on the Earth. We will educate our congregation and community on these efforts, and will work to inspire change at all levels.

3. We resolve to elevate climate action, and with it social justice, as a primary focus of our ministry. We will take a multi-faceted approach that includes education, communication, direct action and worship.



#### Green Notes: First Church Supports Climate Lawsuit

Invoking the Climate Covenant adopted by our congregation in 2020, First UMC is formally supporting a landmark lawsuit filed by 16 young Montanans who want the state to consider climate change in all major environmental decisions.

Our support comes in the form of an amicus brief submitted by Montana Interfaith Power and Light, describing faith-based environmental stewardship principles and the need to protect Montana's air, land and water for present and future generations.



Interfaith Power and Light's brief supports the young Montanans in their efforts to address the impacts of climate change, utilizing the state Constitution's guarantee of a "clean and healthful environment" for all Montanans. In part, the brief cites Article IX, Section 1 of the 1972 Constitution: "The state and each person shall maintain and improve a clean and healthful environment in Montana for present and future generations."

Held v. Montana alleges the state has violated that constitutional guarantee and focuses on a provision in the Montana Environmental Policy Act that prohibits state agencies from considering greenhouse gas emissions and climate change impacts while conducting environmental reviews.

Last summer, State District Judge Kathy Seeley ruled in favor of the plaintiffs, writing that "as children and youth, they are disproportionately harmed by fossil fuel pollution and climate impacts." Montana's attorney general immediately appealed to the state Supreme Court. That's who will see the amicus brief now being submitted by Interfaith Power and Light.

Here's the statement of support submitted this week by Missoula FUMC's Green Team:

Missoula First United Methodist Church has tended the same corner of downtown Missoula since filing the city's 11th recorded plat in 1871, providing a stable, progressive, activist presence in the heart of our community for the ensuing 153 years. We are guided by a Climate Covenant unanimously adopted by our annual Charge Conference in 2020. In part, that document issues a call to action: "We resolve to accept our moral obligation to be responsible stewards of God's creation and advocates for social justice. ... We pledge ourselves – as individuals and as the congregation of Missoula First United Methodist Church – to the interconnected responsibilities of caring for creation and seeking justice for the oppressed. All aspects of our congregation's life will reflect these deep and unwavering commitments." We care deeply about the future we leave our children, grandchildren and their children on this planet – and are committed to taking whatever action is needed to ensure that future is livable.
